1. Purpose and aims of the Board



The aim of the LDPB is to work together in partnership with stakeholders, to help adults who have a learning disability and their families to lead fulfilling and rewarding lives.



The LDPB aims to help people have the same opportunities as everyone else.

To make this happen, the Partnership Board will:



Check that local (Devon) and national plans for people who have a learning disability are being put into place across Devon.



Support these plans and what they aim to change as much as possible.



Check and say if the Annual Health & Social Care self- assessment framework is a true view of services in Devon.



Give a view on new policy and strategy locally and nationally, and also about key issues and events that happen related to people who have a learning disability.



People who have real life experience can use the Partnership Board to tell people who make decisions where things need to bet better and how things can change to make sure that best practice takes place.



To be active in supporting o key issues that affect peoples lives. These are decided on at the beginning of each year.



2. Principles (standards) The Devon Learning Disability Partnership Board will;



Be aware of the health and wellbeing needs of people with learning disability.



Be informed by and contribute to the Joint Strategic Needs Assessment (JSNA) in respect of Learning Disability.

The JSNA tells us about the needs of the Learning Disability Population in Devon.



Make sure that the needs of people with a learning disability are written into other strategies and plans.



Take action where reasonable adjustments are necessary and not being made.



Provide feedback to stakeholders on the work of the Board



Celebrate and tell others about the achievements of the Partnership Board.



Look at and think about guidance and policy at a national and local level.



Promote the values and principles of the "Living Well with a Learning Disability in Devon" strategy.



The Partnership Board will address the needs of adults with learning disabilities and those young people who are preparing for adulthood (aged 14 and over).



It will also keep clearly in mind the needs of carers with a learning disability, linking to the carer's strategy.



Ensure the engagement and involvement of people with a learning disability and their family carers.

3. Governance of the Devon Learning Disability Partnership Board



The Devon Learning Disability Partnership Board is set up in line with national guidance.



The Devon Learning Disability Partnership Board will report to the Learning Disabilities Partnership Group



The Learning Disability Partnership Group will give updates when needed to the Joint Commissioning Coordinating Group (JCCG) and the Health & Wellbeing Board.



The Learning Disability Partnership Group will sign off (agree) the Terms of Reference.




Members of the LDPB should make sure the organisation they work for or network they represent is kept up to date about the work of the LDPB.

4. Who comes to the LDPB meetings



The LDPB is made up of people from lots of different organisations.


5. Meetings
